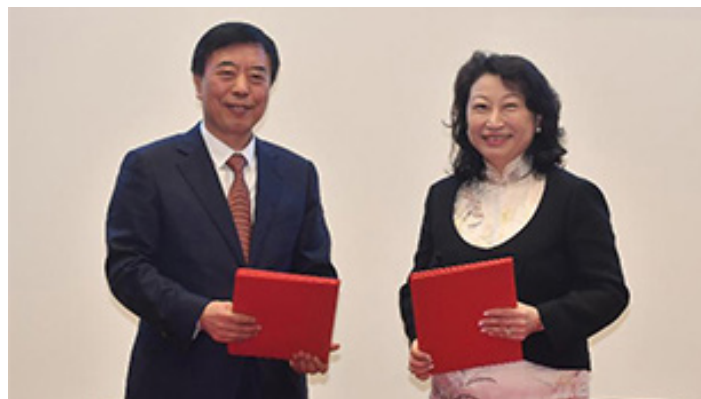

Enhancement Measures of the BUD Fund Attracted 768 Applications in Seven Months

Since 2012, the Government launched a HKD1 billion BUD fund to support companies to enhance their competitiveness in domestic market. In August 2018, an additional HKD1.5 billion was allocated to support the business development in the ASEAN and Mainland markets. According to Mr Clement Li, General Manager of Management Consulting of Hong Kong Productivity Council, the enhancement measures of the ASEAN markets and Mainland programme received 768 applications while 208 cases were approved with a total funding support of HKD115 million, and the application number is expected to increase. 為協助企業發展品牌及拓展市場，港府於2012年起推出一項總值10億元的BUD專項基金，其後額外注資15億元，並於去年8月將資助地域擴大至東盟市場。香港生產力促進局管理諮詢總經理李寶雄表示，東盟計劃和優化版內地計劃收到768宗申請，並已批出208宗，總資助額約1.15億元，預料市場對專項基金的申請需求將持續增加。（資料來源：經濟日報2019年3月22日）
